Business Pledge for a Nuclear Weapons Free World

The 2017 Treaty on The Prohibition of Nuclear Weapons makes everything to do with nuclear weapons illegal under international law. I hereby pledge, on behalf of the business named below, that from this point forward we will comply with this Treaty, as far as we are able, by:

1. not being directly involved in the research, manufacture, handling, transport or deployment of nuclear weapons;
1. not supplying or contracting with any of the companies¹ that make or deal with nuclear weapons themselves;
2. not purchasing goods or services from those companies;
3. not having any money invested directly in any of those companies;
4. spreading awareness about the Treaty through publicly identifying as a Treaty-Aligned business.

Nuclear weapons are the most destructive, inhumane and indiscriminate weapons ever invented. A single detonation – on purpose or by accident – would be a humanitarian catastrophe of unparalleled proportions. A “limited” exchange of nuclear weapons, for instance between India and Pakistan or between the US and North Korea, could put enough soot into the atmosphere to cause climate disruption and global famine. A full-scale nuclear war between the US and Russia would be the end of human civilization as we know it, if not the end of all life on earth.

The Treaty on the Prohibition of Nuclear Weapons was adopted by 122 nations at the UN on 7/7/17. The Treaty comprehensively bans the development, production, possession, deployment, threat and use of nuclear weapons under international law. It also makes it illegal to “assist, encourage or induce, in any way, anyone to engage in any activity prohibited to a State Party under this Treaty.” (Article 1e)

The US has so far refused to sign, but as with the Paris Climate Accords, we the people of the US do not need to wait for the President or Congress to do the right thing.

Individuals, faith communities, cities, schools, businesses and organizations across the country are taking steps *themselves* to comply as far as they are able with this new Treaty – by divesting from and boycotting the companies involved in the nuclear weapons industry and by refusing to work for or supply to these companies.

The following companies are directly involved in the production and maintenance of nuclear weapons and are thus in violation of the Treaty on the Prohibition of Nuclear Weapons:
